Designed & deployed a daily automated volatility screener, identifying and ranking the top 5 equities with High IV Rank relative to SPY and their respective sectors for options selling, reducing manual analysis by 15 hrs/week.

Designed and backtested a weekly put/call credit spread strategy using IV Rank (vs. market/sector) to identify overpriced volatility and RSI/BB/Beta Adjusted Performance for directional bias, achieving 83% win rate, generating ~\$80 credit while risking \$500 each trade, with an expected value of \$31 per trade.

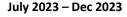
